1. This application must be accompanied by a non-refundable \$50.00 application fee (Checks payable to Metacon Gun Club).
2. All applicants are required to have either a valid CT Pistol Permit OR a completed State of Connecticut Criminal History check (DPS-0846-C) at the time your name moves to the top of the wait list. Current fee for background check is \$75.
3. This application must have (2) two sponsor signatures before it is accepted.
4. All applicants must pass our Certified Range Officer class (CRO). Classes are listed on the calendar and are free.
5. Application must be submitted in person at any general meeting. Meetings are every third Tuesday of the month at 7:30PM at 106 Nod Road, Simsbury CT.

If accepted for membership, I promise to abide by the provisions of the By-laws and all rules & regulations. I understand that the Metacon Gun Club is made up of non-paid volunteers who work together to maintain the Club property and I will be asked to work at work parties or participate in Club activities freely. I understand that I must take the Range Officer Training Course before my probationary period and that in order to be allowed access to the indoor range, I must be qualified by a designated member of the club.
